

Fiscal Year 2017 Tuition and Required Fees

In December 2015, preliminary information about recommended changes to tuition and required fees was presented to the Board. These proposals have been refined and adjusted. This page provides a summary of FY2017 recommendations, which are being presented for approval at the May 18, 2016 Board meeting. Rationale for the increases and details of the recommendations are provided on the following pages.

- Undergraduate and graduate resident and nonresident tuition rates are proposed to increase as shown in the table below. Resident undergraduate rates will remain flat.

- Professional school tuition rates are proposed to increase from 0.7% to 6% depending on the program. The exception is the UMKC Graduate Nursing tuition rate which was approved last year to be phased in over a two year period.
- Required fees are proposed to increase at the rate of inflation.
- All tuition and required fee proposals are in compliance with the Higher Education Student Funding Act (HESFA, SB389). No waiver is required.

Recommended Action - Fiscal Year 2017 Tuition and Required Fees, UM

It was recommended by the respective Chancellors, endorsed by Interim President Middleton, recommended by the Finance Committee, moved by Curator \_\_\_\_\_ and seconded by Curator \_\_\_\_\_, that the attached schedules of rates for tuition, information technology fees, and student activity, facility and service fees, be approved, effective with the 2016 fall term.

1. Tuition and information technology fees as shown in the attached schedules and described in the Board materials be approved and become effective beginning with the 2016 fall term. Specifically this includes:
  - a. Tuition rates to increase as follows:
    - i. Resident undergraduate tuition to remain unchanged.
    - ii. Nonresident undergraduate tuition to increase by 3%.
    - iii. Resident graduate tuition to increase by CPI (0.7%) at MU, 4% at UMKC, 3% at S&T, and 2% at UMSL.
    - iv. Nonresident graduate tuition to increase by 3% at MU, 4% at UMKC, 6% at S&T, and 4% at UMSL.
    - v. UMKC Graduate Nursing tuition rate will increase \$50 per credit hour in year 2 of 2 of the rate phase-in approved in FY2016.
    - vi. Professional school tuition to increase from 0.7% to 6%.

All increases are rounded to the nearest \$0.10.
  - b. Information Technology fee will increase by CPI (0.7%) rounded to the nearest \$0.10.
2. Student activity, facility and service fees as shown in the attached schedule and described in the Board materials be approved and become effective beginning with the 2016 fall term.

Following are recommendations regarding tuition and required fees effective beginning with the 2016 fall term. Specifically, the materials include recommendations concerning undergraduate tuition, graduate tuition, professional schools tuition, information technology fee, and student activity, facility and service fees. Fee rate schedules are located at the end of the document.

**Higher Education Student Funding Act (HESFA) Tuition and Required Fees**

Undergraduate tuition and required fees charged to all Missouri resident students are governed by the Higher Education Student Funding Act (HESFA, Section 173.1003, RSMo), commonly referred to as SB389. Tuition and required fees typically includes base tuition, information technology fee, and student activity, facility and services fees. In FY2014 UMSL restructured their tuition rates to include base tuition and all required fees, and thus eliminated separate billing for other required fees. The Higher Education Student Funding Act modifies the definition of tuition and required fees to exclude fees passed by student referendum or officially recognized student government organizations popularly elected by the students on campus. These include student union fees at MU (\$72) and UMKC (\$390.90), intramural facility fee and student services fee at S&T (\$75.80), and at UMSL, Metro pass program fee (\$48) and student wellness and recreation center fee (\$517.50).

The table below shows tuition and required fees for a Missouri resident undergraduate student as defined by the Higher Education Student Funding Act (SB389.) FY2017 tuition rates for a University of Missouri resident undergraduate are proposed to remain unchanged and required fees are recommended to increase by CPI of 0.7%.

Nonresident

Nonresident undergraduate tuition rates are recommended to increase 3% for all campuses. This recommendation is based on economic and market circumstances of each of the campuses. Rates for FY2016 and proposed rates for FY2017 are shown below.

**Graduate Tuition**

Resident and Non-Resident

Resident graduate tuition rates are recommended to increase 0.7% at MU, 2% at UMSL, 3% at S&T, and 4% at UMKC. Nonresident rates increase 3% at MU, 4% at UMKC and UMSL, and 6% at S&T. These recommendations are based on economic and market circumstances as well as the strategic plan of each of the campuses, and is detailed for residents in the following chart.

UMKC and UMSL have Metropolitan graduate tuition rates for students from Kansas and Illinois counties in their market area. The Metropolitan tuition rates are same as Missouri resident rates.

In FY2016, a differential tuition rate was approved for the UMKC graduate nursing program. Approved rates included a two-year phase-in of the differential tuition with an increase of \$50 per credit hour in FY2017 for both resident and nonresident rates.

### Professional School Tuition

Professional school tuition rates are recommended to increase at varying levels based on cost and market analysis of the particular schools and their relationship to campus strategic plans. These recommendations are summarized below.

### Information Technology Fee

The information technology fee is recommended to increase by the CPI (0.7%) or \$0.10 per credit hour to \$13.20 at MU, \$13.80 at UMKC and \$14.00 at Missouri S&T.

## **Student Activity, Facility, and Service Fees**

Total student activity, facility, and service fees are proposed to increase by the CPI (0.7%). A schedule showing proposed FY2017 student activity, facility, and service fee rates for each campus compared to FY2016 approved rates is located at the end of this document.

Increases in undergraduate activity, facility, and service fees are 0.7% or \$3.00 at MU, \$3.33 at UMKC, and \$3.30 at Missouri S&T.

Fee proposals were prepared under the direction of the Vice Chancellors or Vice Provosts for Student Affairs on each campus. Planning for fee changes are conducted using operating assumptions unique to each campus and activity, within the context of general economic guidelines communicated by the Assistant Vice President of Budget and Planning. Appropriate advisory groups, affected students, and/or their elected officers reviewed and supported the activity, facility, and service fee proposals.

These rate changes are in compliance with the Higher Education Student Funding Act (HESFA, commonly known as SB389.) Increases in required fees charged to all Missouri resident undergraduates do not exceed the annual rate of inflation, which was 0.7% as of December 2015.

Graduate and professional student fees increase by 1% at MU and 0.7% at UMKC and Missouri S&T.

Fees are assessed predominantly on a per credit hour basis with a plateau of 12 credit hours per semester and six credit hours for the summer session. However, at MU, the graduate and professional student plateau is nine credit hours per semester. Some fees are assessed at a flat rate per semester, or have a lower plateau, such as the student services fee at Missouri S&T.

The **MU** Club Sports fee of \$3.45 was moved from the Undergraduate Student Activity fee to the Recreation Activity and Facility fee. With this movement, the student activity fee component will decrease \$2.28 per semester and the recreation activity and facility fee will increase \$4.54 per semester. Student activity fees include fees to fund: student government, student organizations, multicultural student organizations, readership program, sustainability program, Associated Students, capital improvement, divisional councils, transportation system, student unions, student life, counseling center, Jesse Auditorium, and parking garages. The Student Health Services Fee will increase by \$0.74. The total increase will be \$3.00.

The **MU** Student Fee Review Committee, which is comprised of a representative mix of undergraduate and graduate students, annually reviews activity, facility, and health service fees in detail. They make a recommendation to the Vice Chancellor of Student Affairs regarding any increases or reallocations. The proposed increases represent the Committee's recommendations.

**UMKC** total student activity, facility, and service fees will increase at 0.7% or \$3.33. The student activity fee provides funding for the student government association, academic student councils, student organizations and clubs, and student involvement. The athletic fee supports UMKC's NCAA Division I intercollegiate athletics program. Facility fees include the University Center, student union, physical plant facility fee, and recreation facility fee, which funds the Swinney Recreation Center and student intramurals. The student health fee provides health services and outreach to students.

**Missouri S&T** student activity, facility, and service fees are proposed to increase by 0.7% or \$3.30 a semester. The \$3.30 increase is for the University Center fee with other fees remaining flat.

In FY2014 the **UMSL** campus restructured their tuition and required fees into a base tuition rate. The campus no longer assesses student activity, facility, and service fees separately.
